**WE ARE PLEASED TO PRESENT** the 2024 Hawai‘i Directory of Public Officials, a comprehensive guide to all federal, state and county elected officials. The corresponding digital app — KĀKOU — can be found for free online, making it convenient to connect with local leaders who shape public policy that affects our families’ lives and livelihoods.

In this important election year, engaging with our government officials at hearings and meetings is more critical than ever as we address our communities’ most pressing needs. After all, sincere engagement and active participation in the civic process is the only way progress and positive change will be made.

To this end, PRP launched Partners for Democracy in 2022, a nonpartisan civic leadership program for those with a deep interest in running for public office or creating compelling advocacy campaigns. Our second cohort, comprising 28 individuals throughout Hawai‘i, seeks to contribute significantly to the improvement of our island home. Their 10-month program will conclude this March, and we are excited to have several of our members run in the upcoming 2024 election to serve in the Hawai‘i State Legislature and county councils.

PRP will continue to advocate for public policies that prioritize building affordable housing and achieving a truly livable wage that supports local families. Additionally, PRP will prioritize innovative solutions that grow our economy in a sustainable way. Through Partners for Democracy, we will continue to diversify the political landscape, encourage civic engagement, and develop future leaders — all for the betterment of Hawai‘i.


